Terms & Conditions

GENERAL CONDITIONS

- 1. This certificate is valid for the period of the validity of the Kenyan Standard under which it is issued
- 2. The certificate holder shall not transfer or otherwise divest any rights, powers or obligations conferred or imposed on the registered company by the certificate without permission from the Energy and Petroleum Regulatory Authority
- 3. The holder of appliance model registration certificate shall ensure replacement of the certificate if lost, defaced or destroyed. For a lost certificate, the holder shall provide a police abstract
- 4. The holder of appliance model registration certificate shall submit annual record of all appliances sold every year in as provided for in the Fourth Schedule of the regulations within six months after the end of the calendar year or when requested by the Authority.

Specific Conditions

- 1. The holder of appliance model registration certificate shall import registered appliances only.
- 2. The holder of this appliance model registration certificate shall affix the applicable energy label approved by the Authority on every appliance that has been registered. The label shall be in the form approved by the Authority from time to time and appropriately located as provided in the Fifth Schedule of the regulations.
- 3. In cases where the applicable standard under which a model registration certificate was issued is revised, the holder of the appliance model registration certificate shall apply for a fresh registration of the model.
- 4. All marketing channels including online, brochures, print media and television MUST include information of the energy label for which the appliance model registration certificate is issued
- 5. Contravention of the general and specific terms and conditions herein shall lead to certificate revocation and legal action
